Guidelines/SOP for State Poster Making Competition under NPEP

- 1. The Theme on which Posters are to be designed and drawn is: Children's Rights.
- 2. The Competition is open for the students of Class VIII and IX of Government Schools only.
- 3. Schools are required to organise the Poster Making competition for the respective classes as mentioned above and forward the first prize winning Poster as the entry for State Level Competition to be organised at SCERT, Goa on 20th December 2024. Only one entry to be submitted per school.
- 4. The schools have to submit a brief report of the competition held in the school along with the entry Poster. The Brief Report of school must include the date of organisation of competition, number of students participated from different class and the name of prize winners.
- 5. The posters should be drawn/designed on A3 size paper with water colour. Details of the student that is name, class and roll no. should be clearly mentioned at the bottom of the Poster.
- 6. The entry Poster to be submitted on PDF or JPEG format by taking a clear colour picture of the 1st prize winning poster in a high-resolution camera.
- 7. Entries are to be submitted along with the Brief Report of the Competition held in the school via email to: skpscertgoa@gmail.com latest by 30th November 2024. Hard copies are not to be sent to SCERT.
- 8. No entries will be accepted after the last date. Entries without the Brief Report of School or the Posters prepared and submitted without the specifications stated above shall be rejected.
- 9. All valid entries will be assessed by two Subject Experts to be decided by PEC, SCERT to select the best 15 posters for participation at State Poster Making Competition. Selected posters will be notified by 10th December 2024. The schools will be intimated about the same accordingly.
- 10. The students whose posters are selected for the State Level Competition shall have to draw/design/make the same Poster live within a stipulated time at the venue.
- 11. There will be three prizes for 1st, 2nd and 3rd position. All participating students will be provided with an appreciation certificate.
- 12. The students who will be intimated to participate in State Level Poster Making Competition at SCERT have to bring their own drawing material, colour, brush etc. Paper will be provided by SCERT. Students and their accompanying teachers have to arrange for their own conveyance. SCERT will not pay any TA/DA to teachers or students. However, refreshment and lunch will be provided at the venue.

Guidelines/SOP for State Health and Wellness Quiz Competition for HWMs

- 1. The Competition is open for the HWM (Health and Wellness Messengers) of Class VIII and IX of Government Schools only.
- 2. At the selection round the HWMs are required to send a write-up on the following: "Give a brief appraisal of yourself as Health and Wellness Messenger". The write-up should be in about 500 words.
- 3. The students should prepare the write-up in his own words in English.
- 4. The entry should be preferably neatly handwritten.
- 5. Name, Class and Roll Number of the student must be clearly mentioned at the bottom of the write-up.
- 6. The entry should be certified by the Headmaster of the school by having the endorsement of the same on the entry.
- 7. Maximum of two entries: one boy and one girl should be sent to SCERT for consideration.
- Entries are to be submitted via email to: skpscertgoa@gmail.com latest by 30th November 2024. Hard copies are not to be sent to SCERT.
- 9. No entries will be accepted after the last date.
- 10. All valid entries will be assessed by two Subject Experts to be decided by PEC, SCERT to select the best 15 posters for participation at State Health and Wellness Quiz Competition for HWMs.
- 11. Top 15 selected Entries of Students will be notified by 10th December 2024. The schools will be intimated about the same accordingly.
- 12. The students whose entries are selected for the State Level Competition shall have to report to SCERT on 20th December 2024 for the Quiz Competition.
- 13. At the final round of Quiz Competition, Students will be asked answer certain number of MCQs (Multiple Choice type of Questions) on the Health and Wellness Themes. Each correct answer to MCQ will be awarded 2 marks. The final score will determine the winner.
- 14. In case there is a tie for the top rank then question will be asked verbally to break the tie to determine the winner.
- 15. There will be three prizes for 1st, 2nd and 3rd position. All participating students will be provided with an appreciation certificate.
- 16. Students and their accompanying teachers have to arrange for their own conveyance. SCERT will not pay any TA/DA to teachers or students. However, refreshment and lunch will be provided at the venue.
