As per the Scheme, the student is eligible for the scholarship, whose parental Income does not exceed Rs. 3,50,000/- per annum from all sources.

The above qualified students should possess/open Saving Bank A/C (Zero balance) Compulsory seeded with Adhar Number of the beneficiary preferably in any State Bank of India or any other Nationalized Bank, as the scholarship amount will be directly credited to the beneficiary's account though DBT. Note that no disbursement shall be made to the beneficiaries if their Bank Accounts are not complied for Aadhaar Payment Bridge (APB). Refer enclosed circular 1)No. MISC/6/4/2021-Fin(Bud)/Part/908 dated 17/11/2023 and 2)No.MISC/6/4/2021-FIN(Bud)/Part/17600 from Under Secretary (Finance Budget-I), Secretariat, Porvorim and payment shall be made under the Scheme to only those beneficiaries whose bank account are Aadhaar seeded. The Bank Account details Should be of the student only and NOT of the Parents.

It is Mandatory for the beneficiary to get registered on National Scholarship Portal 2.0 (NSP 2.0) as soon as portal start functioning which is expected in the month of June/July 2025. The portal is available on [www.scholarship.gov.in](http://www.scholarship.gov.in) .



3. Self-attested copy of Aadhar card of the beneficiary.
4. Attested copy of mark sheet of annual Report of Std. VIII.
5. Contact number (Mobile number) of the beneficiary & e-mail address.
6. UDISE Number of the Institute where the beneficiary Student is studying at present.

**CIRCULAR**

Read:- MISC/6/4/2021-Fin (Bud)/part/908 dated 17/11/2023 (copy enclosed)

The Government of Goa, through the aforementioned circular had directed all heads of department to ensure that disbursements to beneficiaries under state schemes be made exclusively through the Aadhaar Payment Bridge (APB) thus prohibiting transfer via bank accounts.

However, it has come to the Government's attention that many departments are yet to adhere to these instructions. It therefore directed that strict compliance of the above circular be ensured and payment shall be made under State schemes for releases to only those beneficiaries whose bank account are Aadhaar seeded.

The same shall be periodically revived by this department and the respective scheme in-charges of the department shall be held responsible for non-compliance of circular read above.

This is for strict compliance.

C I R C U L A R

Government of India has focussed on timely completion of Biometric Aadhaar Authentication of beneficiaries under the Centrally Sponsored Schemes (CCS) to ensure 100% Aadhaar Payment Bridge (APB) in all Centrally Sponsored Schemes (CCS) in the state of Goa.

Now, it has been decided by Government of Goa to take similar initiative in respect of State Schemes. In view of same, it may be ensured by Heads of Departments that hence forth all the disbursements to the beneficiaries shall be done through Aadhaar Payment bridge only and no disbursements shall be made through Bank Account based transfers on or after 01/04/2024.

The above instructions shall be strictly complied with and Heads of Departments shall put in place a mechanism before 01/04/2024 for disbursing the benefits only to the Aadhaar seeded bank accounts for State Schemes.
